#### Practice at the Bar

My practice is primarily in the areas of Administrative Law, Family Law, Civil/Human Rights & Discrimination and Child Protection Law. I accept a number of deserving *pro bono* briefs.

I have also appeared on occasions in the Appellate Division of the Supreme Court.

I also appear frequently in the Family Court, both in the trial and appellate division, as well as in the Federal Circuit Court on a regular basis. I appear for Governments (as Interveners), for the Independent Children's Lawyer and for private litigants.

Much of my practice in the District Court of Queensland is focused on s. 222 appeals, formerly some appeals from QCAT and from the Children's Court (normally for the Crown) and for regulatory matters.

I also maintain a practice in Coronial Inquests, appearing as Counsel Assisting to the Coroner and for various Hospitals.

I have appeared as junior counsel to the Solicitor General in a number of special leave applications to the High Court of Australia.

Aside from my court work, I am an accredited mediator, both as a mediator and acting for litigants.
